ORDER

Provisional affiliation was granted to Kunhathumma Memorial College of Teacher Education (Unaided), Valillapuzha, Areacode, Malappuram for starting B.Ed Degree programme during the academic year 2003-04 with an intake of 150 students, vide U.O read as 1<sup>st</sup>.

2. Continuation of Provisional affiliation was granted to the B Ed programme for the academic year 2020-21 on conditional basis subject to the submission of renewal NOC vide U.O read as 2<sup>nd</sup> and followed by a revised permanent seat distribution was granted among different optional subjects in the B.Ed programmes at various affiliated training colleges from the academic year 2020-21 onwards with re-arrangement of seats for the academic year 2020-21 ,vide the U.O read as 3<sup>rd</sup> .

3. The Principal, K.M. College of Teacher Education, Valillapuzha, Malappuram vide paper read as 4<sup>th</sup>, has requested to grant continuation of provisional affiliation to the B.Ed Degree programme for the academic year 2021-22. An amount of ₹1,32,300/- (Rupees One Lakh Thirty Two Thousand Three Hundred only) towards the fee for Administration/ Affiliation has been remitted vide chalan No.202159088 dated 30.11.2020.

4. Vide paper read as 5<sup>th</sup>, the National Council for Teacher Education, Southern Regional Committee, Bangalore has permitted the K.M. College of Teacher Education, for conducting B.Ed degree programme of two year duration with annual intake of 100 students (two units) from the academic session 2015-16.

5. Vide paper read as 6<sup>th</sup>, the National Council for Teacher Education, Southern Regional Committee, Bangalore has reduced the intake from 2 units to 1 unit at the K.M. College of Teacher Education, for conducting B.Ed degree programme of two year duration .

6. Vide U.O read as 7<sup>th</sup>, orders were issued to implement the Syndicate resolution 2017.031\* and to grant continuation of provisional affiliation to each batch of the Teacher Education Colleges, at the beginning of the course keeping the existing formalities without insisting order for extention of approval from the NCTE.

7. Vide G.Os read as 8<sup>th</sup>, Department of Higher Education, Govt. of Kerala has renewed the NOC for conducting self financing B.Ed Course at K.M. College of Teacher Education, Valillapuzha, Malappuram from the year 2013-14 to 2021-22.

8. The Principal has submitted the staff list with an undertaking as stipulated vide U.O read as 9<sup>th</sup> .

9. Considering the above, sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the B.Ed programme at K.M.College of Teacher Education (Unaided) Valillapuzha Malappuram (Dt.) for the academic year 2021-22 and making vide U.O read as 2<sup>nd</sup> as absolute, since the

College has produced renewal NOC from the Govt. for the academic year 2020-21.

10. Following orders are, therefore, issued.

i) Continuation of Provisional Affiliation is granted to the B.Ed programme at K.M.College of Teacher Education (Unaided) Valillapuzha , Malappuram (Dt.) for the academic year 2021-22 as detailed below:

ii) Continuation of Provisional Affiliation granted to B.Ed programme conditionally during 2020-21, vide U.O. read as 2<sup>nd</sup> , is made absolute.

11. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the directions issued by the University/ Government from time to time, failing which the affiliation granted will automatically be cancelled.

12. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998 the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

13. Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for the continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University, along with a copy of the letter of extension of approval from the National Council for Teacher Education.

14. As per the U.O No.5869/2015/Admn dated 09.06.2015, the conduct of University Examinations of any sort, including that of S.D.E Examinations, is compulsory and binding on all colleges affiliated to the University of Calicut.

15. A list of colleges, which have renewed their provisional affiliation will be forwarded to the office of the Controller of Examinations to ensure that examinations are not conducted in the colleges without having valid affiliation order.

16. Admission to the next academic year shall be made only after obtaining prior permission from the University.
